Wheatland Charter Academy will present the School Site Plan and Title I Parental Involvement Policy each year at the fall charter council/school site council meeting. At this time all Wheatland Charter Academy teachers are Highly Qualified, and all Wheatland Charter Academy Programs have met annual academic goals (high school graduation rate was not met for 2008/09, however the high school portion of the charter ended service as of June 2009), so there is not the need to distribute Parent Deficiency Notices. The School Accountability Report

Cards are located in the office and available upon parental request and are posted on the school website when released. Parents shall receive timely information about the programs and shall have opportunities to meet regularly to formulate program input if desired. Parents will be kept apprised of student progress with trimesterly progress reports and trimesterly report cards. Insofar as practical, individual parent-teacher conferences also shall be held to discuss the student's progress and placement and to describe methods the parents can use to complement the student's instruction. Written SEA complaint procedures are available upon parent request in the school office.

- 2. Wheatland Charter Academy will take the following actions to distribute to parents of participating children and the local community, the School Parental Involvement Policy:
